MISSION

The Air Force Rescue Coordination Center (AFRCC) serves as the single agency responsible for coordinating on-land federal Search and Rescue (SAR) activities in the 48 contiguous United States also known as the Langley Search and Rescue Region (SRR). The Commander, United States Northern Command (CDRUSNORTHCOM) is designated as the Inland SAR Coordinator (ISC) and the Commander, Air Forces Northern (AFNORTH) has been delegated this responsibility. The Commander, AFRCC is designated as the SAR Mission Coordinator (SMC). The AFRCC seeks to encourage a cooperative SAR network and help coordinate assistance for persons in distress.

AUTHORITY

The AFRCC mission is derived from international treaty requirements in the Chicago Convention (ninth addition, 2006) and the International Aeronautical and Maritime Search and Rescue (IAMSAR) Manual. These requirements are satisfied by the U.S. via the National Search and Rescue Plan (NSP) and the National Search and Rescue Supplement (NSS). The NSP and NSS provide the United States a national plan for coordinating SAR services to meet our domestic needs and international commitments. Further implementation guidance is provided in Department of Defense Instruction 3003.01, *Support to Civil Search and Rescue* and Air Force Policy Directive 10-45, *Air Force Support to Civil Search and Rescue*.

TASKING AUTHORITY

The AFRCC has no command or control tasking authority. The AFRCC supports domestic civil authorities by fully coordinating Department of Defense (DoD) and other federal SAR services practicable on a non-interference basis with the unit's primary duties, according to applicable national directives, plans, guidelines, and agreements. No DoD or other federal resources are assigned or tasked for the aeronautical civil SAR mission, within the continental U.S.


RESPONSIBILITIES

When managing SAR operations, the AFRCC has the full operational authority of the Inland SAR Coordinator.

Specific responsibilities include:

- Coordinating SAR operations involving overdue General Aviation (GA) interstate flights, DoD aircraft, commercial aircraft, and missions of national concern.
- Coordinating SAR operations in response to Emergency Beacon Alerts. The AFRCC receives all COSPAS-SARSAT emergency beacon distress signals registered to the United States or those originating from within its SRR. The AFRCC investigates the signal in coordination with federal, state, and local officials and determines the required type and scope of response.
- Coordinating federal SAR capabilities (both Aeronautical and Inland) at the request of other designated Rescue Coordination Centers (RCCs), and Federal and State SAR coordinators in support of their civil SAR operations. Through SAR Agreements with other SAR Coordinators (SCs) and their SMCs, the AFRCC may be a coordinating authority for specific SAR events outside the Langley SRR. These events include mercy, patient transport, search, rescue, and search and rescue unit (SRU) transport.

- 3. Support Your Fellow Controllers


TEN YEAR SYNOPSIS

The AFRCC's yearly activity table illustrates the unit's total operational workload (missions, incidents and saves) over the past ten years.

INCIDENT: A SAR case involving investigation and telephone communications searches. **MISSION**: A SAR case in which assets have been committed to actively search.

Note: all missions are also incidents.

SAVE: An objective was in a distress situation, could not self-recover, and was rescued alive.



INCIDENT/MISSION/SAVE SUMMARY

The incident/mission/save summary identifies the number of distress beacon incidents, nonaircraft incidents, aircraft incidents, number of missions and the number of saves the AFRCC coordinated during 2024. Through telephone and internet investigations, the AFRCC resolved 13,316 (96%) of the 13,794 incidents without expending federal resources, saving approximately \$15.2 million dollars and more than 958 thousand work hours. The AFRCC coordinated 478 missions resulting in 231 lives saved.





BEACON INCIDENT/MISSION/SAVES

Note 1: 2,888 additional beacons were coordinated with overseas agencies in more than 50 countries.

Note 2: An "Unreliable" beacon is a message that fails a validation check and does not provide a known 15-digit hexadecimal identification (HEXID/beacon ID). These beacons are not associated with any other beacons the AFRCC prosecuted.

BEACON INCIDENT/MISSION RESULTS


This chart and corresponding table indicate the results of all distress beacon incidents coordinated by the AFRCC during 2024.

NON-DISTRESS: Upon investigation it was revealed that there was not an actual distress situation, e.g. accidental activation, or improper testing.

HAND-OFF: The incident/mission was passed to another Search and Rescue Region/Agency.

CEASED: The beacon was no longer picked up by the source(s) that originally heard the signal (SARSAT, aircraft, ground station), prior to investigative resolution.

DISTRESS: Upon investigation it was revealed that the beacon activation was caused by an actual distress situation.

BEACON INCIDENT/MISSION RESULTS

NON-AIRCRAFT SUMMARY

During 2024, the AFRCC investigated numerous non-aircraft incidents. This chart and corresponding table indicate the type, number of incidents involving federal assets (missions), and the resulting lives saved.

MISSING PERSON/BOAT/VEHICLE: The search for a person or persons/boat/vehicle, whose location is not known.


RESCUE: The extraction of a person or persons in distress from a known location.

MASS RESCUE: SAR services characterized by the need for immediate response to large numbers of persons in distress, such that the capabilities normally available to SAR authorities are inadequate.

MEDEVAC: Evacuation of persons for medical reasons or hospital-to-hospital patient transfers. **MERCY:** Delivery/transportation of life saving vital materials (organs, blood, etc.).

PATIENT TRANSFER: a patient at one medical facility requires transfer to a different facility to save life, limb, or eyesight.

SRU TRANSPORT: Transportation for the Search and Rescue Unit to and/or from a mission location.





Aircraft Incidents and Missions are opened for missing or overdue aircraft when reported from a reliable source such as a concerned party or an Alert Notice (ALNOT) from the FAA.


ALNOT: An Alert Notice issued by the FAA for overdue aircraft.

MISSING AIRCRAFT: The investigation of a missing or overdue aircraft.

PRECAUTIONARY: Pre-positioning of SAR resources at large events where SAR incidents are likely to occur.


