Personnel must travel to a safe haven location located at a minimum of 100 miles and not to exceed a 500 mile radius of Tyndall AFB, out of the projected track, and Warning areas, as identified by the National Hurricane Center.  - The evacuation is effective from 8 October 2018, 1630 CST until 48 hours after the all-clear has been announced.  - Military (including in-status reservists) and civilian members (and their dependents) assigned to Tyndall AFB are qualifying evacuees and will be reimbursed for travel in accordance with the Joint Travel Regulation (JTR). Authorized reimbursement include: Transportation to and in-and-around safe Haven (as required and in accordance with JTR). Per diem to/from safe haven, lodging, and M&IE. Household goods will be reimbursed through the traffic management office (TMO) as required, If any content in this order conflicts with the JTR, the JTR prevails.  - Military and civilian members (and their dependents) who are absent from Tyndall AFB (e.g., on Leave or TDY) as of 8 October 2018, 1630 CST are authorized to remain at their leave or TDY location (if qualifies as safe haven) or proceed to another safe haven location, at the authority of the Tyndall AFB command.  - Use of Government Travel Card is directed for authorized expenses.
